In exercise of the powers under sub-section (1) of section 200 of the Motor Vehicles Act, 1988 (Act No. 59 of 1988) read with section 217 of the said Act and section 27 of the General Clauses Act, 1897 (Act no. 10 of 1987) and in suppression of Government notification no. 2050/xxx-4-98-172-89, dated September. 1, 1998 the Governor is pleased to direct that officers specified in column-1 may compound the offence punishable under section specified in column-2 for amounts specified against each section in column 3 of the Schedule below:-
